

Wake Up the Earth Saturday May 2th 2009

APPLICATION FOR VENDING AND INFORMATION SPACE

By applying to the Wake up the Earth Festival, you agree to the following guidelines:

- Vendors will be assigned places by the vendor coordinator. Lot dimensions will be marked on the street.
- All **tables, signs, tents and props will be supplied by the vendors**. No individual radios allowed in booth.
- No kits or manufactured items to be sold. No balloons are to be sold or given away.
- All vendors will bring 2 trash receptacles, one for waste and one for recyclables.
- **There will be a \$100 fine if food vendors do not bring their own trash receptacles with 10 liners and properly clean their spaces once the festival is over.** Food vendors must include a cleanup deposit fee of \$100 made out as a **separate check** payable to Spontaneous Celebrations. Once your cleanup is approved by the vendor coordinator, this deposit will be refunded to you when you leave.
- **All food vendors must complete the enclosed Temporary Fire Permit and Temporary Food Service Permit applications and return them to Spontaneous Celebrations by April 9, 2009, with their vendor application. The Wake Up the Earth Organizing Committee will obtain these permits for each food vendor.**
- There is no electrical service provided for vendors. For special consideration, please contact the vendor coordinator.
- Priority will be given to local businesses and organizations on a first-come-first-served basis. We reserve the right to deny any application.
- There will be no refunds due to cancellation or postponement.
- Setup times: Craft Vendors 8:30-9:30 a.m. / Food Vendors 9:30-10:30 a.m.
- Each vendor will remain in place from 10:30 a.m.- 5:00 p.m. **All sales most stop promptly at 5:00 p.m.**

VENDOR APPLICATION DEADLINE IS Thursday, April 9th, 2009.
